# President's Message

Kia ora

The end of the year is upon us, with hopefully some good summer weather but less bridge over the next few weeks. The club will re-open on 9 January, though are online programme starts up on 1 January.

There were quite a few changes to the Committee at the AGM, with three of the Committee (Ruth Brucker, Anne-Marie Russell and Stephen Henry) standing down. I would like to thank them for the many years they have been part of the



Committee and the considerable contributions they have each made. We have four new Committee members: Denise McElwain, Lee McDonald, Richard Gawith, and Ruth Harley. It is great to have such capable members appointed to the Committee and I'm sure they will provide valuable thinking and expertise to the management of the club.

The new Committee recently had its first meeting, and the main matters that were discussed were the Auditors report, our Finances with a small loss forecast for the coming year at this stage, start times/supper breaks, and session/event ticket prizes.

Jeremy Morley kindly agreed at late notice to undertake our Audit this year. Jeremy issued an unmodified opinion and found the quality of financial and accounting functions were at a high level. In terms of the key findings of the audit, the majority related to the processes, artifacts maintained and some of the key areas of compliance that the club should meet or provide as a matter of best practice. Four areas that the Committee agreed to focus on were:

- Improve Audit Planning:
- Developing a Statement of Service Performance (SSP) much of the information for an SSP was in the annual report, but as a tier 3 charitable entity the club should have one to formally monitor progress against;
- Develop a risk register for the club;
- Develop a formal policy which describes the delegations that apply to Committee members, management and/or others.

Recently we sent out an online survey to members who play on Wednesday and Thursdays nights as well asking for a show of hands on whether to start club sessions earlier than 7.30pm, and on whether to have supper breaks. This was in response to feedback from some players who favoured slightly earlier starts and some favouring tea breaks and some not.

From a Committee perspective, start times are something that we were keen to get the members who play on those nights views, and if there was a clear majority to change. Whether to have supper on some or all Wednesday and Thursday nights is a little more problematic in that there are additional costs in having a supper break and later finishes, however, member views are clearly important to what we do.

For Wednesday night bridge, there was a clear indication to keep the status quo with 60% of respondents voting for 7.30pm and with 69% wanting either no supper break, or supper during teams and Swiss events only. Only 21% wanted supper every evening.

For Thursday nights 58% of players wanted to retain the 7.30pm start. As far as supper was concerned the vote was close, so we asked for a show of hands on Thursday night which indicated a preference for supper only for teams and Swiss. Our view is that to change what we currently do and what is already in the Programme book, we need a reasonable majority to change the status quo. Tuesday nights starting at 7.15pm with supper has been positively received by Tuesday players so there has been consideration of changing it. Friday afternoons will continue to have afternoon tea breaks.

As I indicated above, the club is currently budgeting a small loss, and as discussed at the AGM the committee decided not to increase the price of club nights. One area that the new Committee has agreed to reduce costs was on the number of free "supper tickets" that are given out. Tuesday nights will remain the same, but for other sessions - there will only be a ticket awarded to the winner of each Series in future rather than the winner of each play night. Bridget in her new role as Development manager will be focused on increasing our revenue and improving the playing experience, and in the first newsletter for the new year I will be able to report to you on progress with some of the initiatives that Bridget is leading.

Thanks to the many members who have been in a position to provide advice and help in so many ways to the club over the year.

I hope you all have a safe and happy Christmas and holiday season, and those who are playing in the Suzanne Duncan tournament over the Christmas period have an enjoyable event. While I'm in Wellington over Christmas I'll be heading to Wanaka for a week in January.
